 - o Butyl Benzyl Phthalate (BBP) 0.1%
 - Dibutyl Phthalate (DBP) 0.1% 0
 - Diisobutyl Phthalate (DIBP) 0.1% 0
 - Solderable products declared RoHS Compliant are also deemed suitable for lead-free soldering, in that any plastic materials used in the construction of the item are chosen for their higher melting temperatures. These higher melting temperatures should assist the product in resisting the higher soldering temperatures associated with leadfree soldering processes.
