

## Statement of RoHS Compliance

Part Number: **G125-MC208M1-1D1D-XXXXM1**  
Product Description: **8+2 Pos. Male 28AWG+18AWG Cable Assembly, double-end, Screw-Lok**  
EU RoHS Status: **RoHS Compliant (2015/863/EU) with Exemption 6c**

### Notes:

- a. RoHS Compliance is declared in accordance with the homogeneous material limits given in EU Directive 2011/65/EU on the Restriction of the Use of Certain Hazardous Substances in Electrical and Electronic Equipment (recast) and any amendments (including Directive 2015/863/EU). If the part is declared RoHS compliant, it meets both the following criteria:
  - Homogeneous materials have a maximum concentration by weight according to the list below, or qualify for an exemption. If an exemption is required, it will be 6c: Copper alloy containing up to 4% lead by weight.
    - Lead – 0.1%
    - Mercury – 0.1%
    - Cadmium – 0.01%
    - Hexavalent Chromium – 0.1%
    - Polybrominated Biphenyls (PBB) – 0.1%
    - Polybrominated Diphenyl Ethers (PBDE) – 0.1%
    - Bis (2-ethylhexyl) Phthalate (DEHP) – 0.1%
    - Butyl Benzyl Phthalate (BBP) – 0.1%
    - Dibutyl Phthalate (DBP) – 0.1%
    - Diisobutyl Phthalate (DIBP) - 0.1%
  - Solderable products declared RoHS Compliant are also deemed suitable for lead-free soldering, in that any plastic materials used in the construction of the item are chosen for their higher melting temperatures. These higher melting temperatures should assist the product in resisting the higher soldering temperatures associated with lead-free soldering processes.
- b. Hand Tooling products supplied by Harwin do not fall under the scope of the RoHS Directive, as there is no electrical current involved in these items. These will show as “n/a” in the RoHS Compliant line at the top of this statement.
